General Site Information:

The building will be open at 7:00 AM both Saturday and Sunday, August 22 & 23.

Doggie U is an indoor site with heat and air conditioning and the running surface is rubber matting.

Parking in the front of the building will be for handicap and officials and for exhibitors waiting to enter the facility. Please observe reserved signs. There is no general exhibitor parking in the small lot immediately in front of the building, or in front of the bay doors and dumpster PLEASE OBSERVE SIGNS FOR RESERVED SPACES. Parking is allowed in front of and around the Master Concepts building. No parking/dog walking directly across the street at CMS. Street parking is also allowed. There is NO RV / Camper or overnight parking availability.

There is a designated "potty" area. Please clean up after your dog and place waste in the receptacles provided. Please **DO NOT** allow dogs to urinate on the building.

NO EX-PENS ALLOWED.

Food: DACLI is proud of its reputation for providing wonderful food for our exhibitors. Unfortunately, during this time, we are using extreme caution so no food or beverage will be available to our exhibitors.

From Southern State Pkwy, take exit 42 North, 5th Ave. Bay Shore. Merge immediately to the left, onto 5th Ave, *turn left onto Spur Dr. North, (there is a McDonalds on the corner), take first right onto 5th Industrial Court. Doggie U is on the left, and you'll see a sign for "Master Concepts", which is in the same building. Spur Drive North is just slightly north of Southern State Parkway.

From Sunrise Hwy take exit 43 North, 5th Ave., then follow from *.

From the LIE, take exit 53, Sagtikos Pkwy, to Southern State Pkwy East, exit 42 North, then follow from *. (Alternate route for commercial or large vehicles, LIE exit 53 (same exit as Sagtikos Pkwy) to Wicks Rd. Travel for 3.8 miles south on Wicks Rd, which becomes 5th Ave, then right on Spur Dr. North, right onto 5th Industrial Court.)

NOTICE TO EXHIBITORS:

NO PRACTICING ALLOWED IN THE RINGS AT ANY TIME.

DOGS MAY ARRIVE any time prior to their scheduled time of judging. However, will not be admitted to the facility until 20 minutes before scheduled ring time. Before entering the facility, handler temperatures will be taken and then issued a wristband which must be worn for the day. We recommend that you have your temperatures taken upon arrival. We will have ez up tents for you to wait under. Teams must pack up and leave the facility as soon as all the classes they are entered in for that day have been pinned. **DOGS NOT REQUIRED** for further judging will be excused.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. The show-giving club and the trial secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ALL DOGS PRESENT must be held on leash or confined to their crates except when being judged.

CLASS CASH PRIZES (if awarded) will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that class is over. The Trial Secretary and Show-giving Club may disclaim any liability for cash prizes after the judging of the class is over.

THE SHOW COMMITTEE will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

BITCHES IN SEASON Bitches in season are not eligible to compete. Entry fees will be refunded subject to a \$5.00 processing fee. Written note from a veterinarian is required. Notification for refund must be received in writing no later than 48 hrs. after the end of the trial.

NO DOGS MAY BE PERMANENTLY REMOVED from the show after the armband is picked up and before it is judged, except by Veterinarian or Judge, or barred from competition by the action of the Trial Committee.

As specified in Chapter 12, Section 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to, snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

Obedience and Rally Trial Guidelines and Procedures
August 22nd and August 23rd, 2020

Obedience and Rally trials are important to all of us in the obedience and rally community. Exhibitors enjoy the camaraderie, the training, the exhibiting their mastery of their skill sets, and earning titles. Due to the Covid-19 virus pandemic, we have had to change many things in our daily lives, and the same is true for obedience and rally. The club has been planning, evaluating and researching ways to safely hold our obedience and rally trials. We will be complying with Governor Andrew Cuomo's guidelines for opening New York State and for gatherings as well as the procedures set forth by Doggie U K9 Academy. DACLI wants all of their exhibitors, workers, and judges to be in a safe environment. As a result, there will be changes to our trial format and we will be imposing new guidelines and restrictions. While obedience is not a contact sport, we believe that the fluid Covid-19 environment demands protocols beyond governmental and AKC guidelines and those are outlined below. Exhibitors not complying with these guidelines and restrictions may be excused from the trial without a refund. All exhibitors will have to sign a Covid-19 Waiver and include it with their entry for the entry to be considered a valid entry. If you are feeling ill for any reason, please STAY HOME! If we suspect an exhibitor is ill, the exhibitor will be asked to leave.

General Procedures

1. Please use a check for your entry fees. If the trial has to be cancelled for any reason, your check will be shredded.
2. If at any time prior to the trial you decide that you cannot follow the procedures outlined in this document, you may withdraw from the trial by informing the Show Secretary. We will then shred your check.
3. When the judging schedule is distributed, exhibitors will be sent specific times that they should arrive. Please follow these times or you may miss your class.
4. When you arrive at the facility, please wait outside until DACLI personnel call your class in to the building. Exhibitors must wear a mask and maintain a 6 foot social distance between people while they are waiting.
5. Upon entering the building, a temperature check will be performed. Please be patient when you enter as this will take time.
6. Masks are mandatory at all times including when you are in the ring as an exhibitor. Please bring your own masks. We recommend bringing multiple masks.
7. Exhibitors should bring their own food and water for themselves and their dogs. There will be no hospitality at this trial.
8. Please wash your hands using the CDC approved procedure frequently. There are no touch soap dispensers in the rest rooms.
9. Please bring your own hand sanitizer or hand wipes. Although the facility has no-touch hand sanitizer dispensers available throughout the facility, you may not always be near one.
10. Refrain from shaking hands, hugging or other physical contact with your fellow exhibitors. We know it may have been a long time since you have seen your friends but we need to stay safe.
11. Please refrain from touching dogs that are not your responsibility.
12. If you think you will need a pen or a pencil, bring your own!!!
13. Know your armband number. It will be emailed/mailed to you with your entry confirmation and the judging program.
14. Do not congregate at the ring or the ring gate.

15. While warming up, please maintain proper social distance.
16. While moving towards the ring, please maintain proper social distance.
17. Crating will be allowed indoors with proper social distance. Please only crate in the indicated spaces so that proper social distance can be maintained.
18. When waiting to exhibit, please maintain social distance from the stewards.
19. When your class is finished, please leave the building so that we do not exceed the numbers of participants that we are allowed to have. No personal equipment (crate, chairs, etc.) may be left after your classes are completed. Everything must be removed so the next group may come in and the staff may clean the common spaces.
20. No unentered dogs or observers will be allowed in the facility.

Steward's Table Procedures

1. Exhibitors waiting to be helped must maintain a 6 foot distance from the steward and the next exhibitor.
2. Stewards will do a "roll call" type of check in. Please be on time for your class so this process can go smoothly. Remember to maintain social distance while listening for your armband number.
3. Rally courses will be available in several places in the building for viewing. We recommend that exhibitors take a photo of the course map on their phone or tablet for their use. Please do not crowd around the course maps.
4. Placement and Q ribbons will be given out in the ring along with any prizes.
5. If you want to make notes about the class order or map, please bring your own writing implement. Do not ask the steward to borrow a pen or a marker.

DACLI thanks you for your support and cooperation. We will try to have the trial run as smoothly as possible but please be aware that this is a first for all of us and there may be some unintended and unexpected delays. Please understand that we are doing our best to keep everyone safe – we want to see you enjoy this time with your dogs. With everyone's cooperation and help, the trial can run smoothly, and we can continue to participate in the sport we love!
